

AN ORDINANCE 2007-01-18-0096

AMENDING THE CITY OF SAN ANTONIO'S MAJOR THOROUGHFARE AS A COMPONENT OF THE SAN ANTONIO MASTER PLAN BY DEDESIGNATING AND DELETING PROPOSED THOROUGHFARES WITHIN THE CITY'S COPORATE LIMITS AND PORTIONS OF ITS EXTRATERRITORIAL JURISDICTION.

WHEREAS, the City of San Antonio Major Thoroughfare Plan was adopted on September 21, 1978 by City Council as a component of the City Master Plan; and

WHEREAS, a public hearing was held on December 13, 2006 by the Planning Commission allowing all interested citizens to be heard; NOW THEREFORE;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The Major Thoroughfare Plan, a component of the Master Plan of the City, is hereby amended by de-designating and deleting various proposed thoroughfares within the City's corporate limits and portions of its extraterritorial jurisdiction. The Proposed Amendments to the Major Thoroughfare Plan as a component of the City of San Antonio Master Plan are more particularly described in Attachments "I" and "II" both of which are attached hereto and incorporated herein for all purposes.

SECTION 2. This Ordinance shall take effect January 28<sup>th</sup>, 2007.
