AN ORDINANCE *MN-238*

APPROPRIATING \$30,500.00 for Payrolls, Special Services, Materials and Supplies.

BE IT ORDAINED by the Commissioners of the City of San Antonio, that,

The sum of \$30,500.00, or as much thereof as may be necessary, be and the same is hereby appropriated for payrolls, special services, materials and supplies as per approved payrolls and purchase orders filed with the City Auditor, out of the following Funds:

Sewer Construction Fund of 1936 - - - - -	\$ 15,000.00
Street Improvement Fund of 1936 - - - - -	5,500.00
River Improvement Fund of 1936 - - - - -	4,000.00
Park Improvement Fund of 1936 - - - - -	6,000.00

It is ordered by a two-thirds vote of the full Board of Commissioners of the City of San Antonio that this Ordinance shall receive final action without having been read at three several meetings of the Commission.

RESOLUTION

DIRECTING THE CITY CLERK TO ADVERTISE A PUBLIC HEARING ON THE 20 DAY OF FEBRUARY, 1936 ON THE ANNUAL BUDGET.

BE IT RESOLVED BY THE COMMISSIONERS OF THE CITY OF SAN ANTONIO:-

1. That the City Clerk is directed hereby to advertise a public hearing on the budget of

the City of San Antonio, filed heretofore with the City Clerk, for the current fiscal year, which hearing shall be held on the 20th day of February A. D. 1936 at 10 o'clock A. M. in the Council Chamber of the City Hall in San Antonio, Bexar County, Texas, and any taxpayer of the City of San Antonio shall have the right to be present and participate in such hearing.

2. Public notice of the hour, date and place of such hearing shall be given by the publication of this Resolution in the San Antonio Light got three times not less than three days nor more than ten days before said hearing.
