AN ORDINANCE **82 17 3**

DECLARING THE RESULTS OF THE CANVASS OF THE REGULAR MUNICIPAL ELECTION HELD ON MAY 6, 1995; ORDERING A RUN-OFF ELECTION FOR CITY COUNCIL PLACES 1, 6, 8, 10, AND 11 (MAYOR) TO BE HELD ON MAY 30, 1995; ESTABLISHING EARLY VOTING SITES AND REGULAR POLLING PLACES FOR THE RUN-OFF ELECTION; AND NAMING AN EARLY VOTING BALLOT BOARD AND A SIGNATURE VERIFICATION COMMITTEE; AND RELATED MATTERS IN CONNECTION WITH THE MAY 6, 1995, ELECTION AND THE MAY 30, 1995, RUN-OFF ELECTION.

WHEREAS, the regular municipal election was held on the 6th day of May, 1995, to determine the Mayor and Council Members of the City of San Antonio for the ensuing term of office of two years; and

WHEREAS, the names of the candidates were submitted, the election was held and conducted and the returns thereof were made, all as required by the City Charter and the laws of the State of Texas; and

WHEREAS, the City Council met on May 8, 1995, to canvass the returns of the said election; and

WHEREAS, it is now necessary to declare the official results of the canvass; and

WHEREAS, at said election, no candidate for Member of Council places (districts) 1, 6, 8 or 10 or for Place 11 (Mayor) received a majority of all the votes for the office sought, cast by the qualified voters voting in said election, and therefore, no candidate was elected at said election for the Office of Member of Council, District 1, District 6, District 8, District 10, or for Mayor; and

WHEREAS, it is now necessary to order a Run-off Municipal Election for May 30, 1995, for the purpose of electing the Members of the Council of the City of San Antonio those districts, and for Mayor; and

WHEREAS, it is necessary to make provisions for the run-off election by naming an early voting ballot board as required by Section 87.001, et. seq. of the Texas Election Code, and a signature verification committee as required by Section 87.027 of the Texas Election Code; and

WHEREAS, it is further necessary to establish early voting sites and regular polling places of the run-off election, and to take other actions related o the May 6, 1995, election and the May 30, 1995, run-off election; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Council having convened May 8, 1995, to canvass the returns of the regular City election held May 6, 1995, after canvassing the returns of said election, does hereby find and declare the result of the election to be as follows:

SECTION 2. It is further declared that as a result of said election, the following persons were elected Council Members for two-year term commencing June 1, 1995:

- Ruth Jones McClendon, Member of Council, Place No. 2
- Lynda Billa Burke, Member of Council, Place No. 3
- Henry Avila, Member of Council, Place No. 4
- Juan F. Solis III, Member of Council, Place No. 5
- Bob Ross, Member of Council, Place No. 7
- Howard W. Peak, Member of Council, Place No. 9

and each of them was elected by receiving a majority of all the votes cast for the office for which each was a candidate cast by the qualified voters of the City of San Antonio voting at said election, and they and each of them are hereby declared to be the lawful and duly elected Council Member of the City for the places specified.

SECTION 3. It is further declared that as a result of said election, no candidate for Places No. 1, 6, 8, 10, or 11 (Mayor) received a majority of all the votes cast by the

qualified voters of the City voting in said election, therefore, no candidate was elected at said election for Member of Council for these places, but that a second or run-off election will be necessary in order that the candidate receiving the highest number of votes shall have received a majority of all the votes cast for the office. The two candidates receiving the highest number of votes for such place in the election shall again be voted for at the second or run-off election.

SECTION 4. A run-off Municipal election for the purpose of electing members of the City Council of the City of San Antonio, places (districts) 1, 6, 8, and 10, and for place 11 (Mayor) is hereby ordered to be held in the City of San Antonio, Bexar County, Texas, on the 30th day of May, 1995, in accordance with the laws of the State of Texas and the provisions of the Charter of the City of San Antonio, and the official ballots for said election shall be prepared in accordance with the Texas Election Code. The two candidates receiving the highest number of votes for places 1, 6, 8, 10, and 11 (Mayor) shall again be voted for at the Run-off Election ordered herein.

SECTION 5. It is further ordered that said election shall be held as prescribed by law, in the City of San Antonio, Bexar County, Texas, at the polling or voting places as set forth in Exhibit A attached hereto and incorporated herein.

SECTION 6. The early voting sites for the run-off election shall be set out in Exhibit B, attached hereto and incorporated herein. Early voting shall commence on Saturday, May 20, 1995, and run through Friday, May 26, 1995, for the hours as set out in Exhibit B.

SECTION 7. In accordance with Section 87.001, et. seq., Texas Election Code, George Rawlings is hereby appointed Presiding Judge of the Early Voting Ballot Board and Manuel Vara is appointed Alternate Presiding Judge of the Early Voting Ballot Board. The Early Voting Ballot Board shall consist of said presiding judge and at least two other members to be appointed by the presiding judge.

Said Presiding Judge shall be authorized to hire a sufficient number of clerks to perform the duties necessary in canvassing the Early Voting Ballots.

The Early Voting Ballot Board Members shall be compensated at the rate of pay that presiding Election Judges receive as provided in Section 87.005, Texas Election Code.

SECTION 8. Because of the large number of mail ballots being anticipated, the early voting clerk has determined it is necessary for the governing body to appoint a Signature Verification Committee for the run-off election. Such a

committee is hereby created for the election as provided for in Section 87.027 of the Election Code. The Committee shall consist of five members:

The City Clerk will notify the members of the newly appointed Signature Verification Committee to convene at the aforesaid times.


