

AN ORDINANCE 2014 - 03 - 13 - 0158

**SELECTING BAIN MEDINA BAIN, INC. FOR NEGOTIATION AND EXECUTION OF AN INDEFINITE DELIVERY PROFESSIONAL SERVICES AGREEMENT IN AN AMOUNT UP TO \$1,300,000.00 TO PROVIDE AN AUTOMATED ASSESSMENT OF PAVEMENT CONDITIONS AND OTHER SERVICES RELATED TO CITY STREETS AND THE ANNUAL DEVELOPMENT OF THE FIVE YEAR INFRASTRUCTURE MANAGEMENT PROGRAM, LOCATED CITY-WIDE.**

**WHEREAS**, the last condition assessment was approved by Ordinance No. 2009-09-17-0739 and was conducted in the FY 2010 and FY 2011 by Fugro Consultants, Inc.; and

**WHEREAS**, the City's Pavement Management System has the Pavement Condition Index score for every street segment in the network; and

**WHEREAS**, the Pavement Condition Index is a key factor used in the development of the Street Maintenance Program to drive project selection and prioritization as well as a guideline to identify the most appropriate maintenance application to be used to either preserve or rehabilitate a roadway segment; and

**WHEREAS**, this Ordinance approves the selection of **Bain Medina Bain** to provide an automated assessment of pavement conditions and other services related to city streets and the annual development of the Five Year Infrastructure Management Program; and

**WHEREAS**, the scope of work includes the collection of data related to surface distresses (cracking, raveling, rutting, etc.) as well as ride-ability to calculate the Pavement Condition Index score for each street segment; and

**WHEREAS**, **Bain Medina Bain, Inc.** will provide an automated pavement condition ratings service necessary to facilitate the development of the Street Maintenance Program over a three-year period; and

**WHEREAS**, in addition to supporting the development of the Street Maintenance Program, the condition assessment also facilitates the City's compliance with the General Accounting Standards Board's Statement No. 34, which was introduced in June 1999 and recommends that governmental agencies report the value of their infrastructure assets in their financial statements;  
**NOW THEREFORE**,

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** **Bain Medina Bain, Inc.** is hereby selected to provide an automated assessment of pavement conditions for the Professional Pavement Management Project.

**SECTION 2.** The City Manager or her designee is hereby authorized to execute an on-call professional services agreement with **Bain Medina Bain, Inc.** in an amount not to exceed

\$1,300,000.00 over a three-year period to provide an automated assessment of pavement conditions and other services related to city streets and the annual development of the Five Year Infrastructure Management Program.

**SECTION 3.** The following financial adjustments are hereby approved:

- a) Funding for this Ordinance will be identified when work orders are issued. If funding for any work orders is not previously appropriated, funding will be identified and appropriated through subsequent City Council action. Payment is limited to the amounts budgeted in the Operating and/or Capital Budget funding sources identified. All expenditures will comply with Operating and/or Capital Budgets for current and future fiscal years.
- b) Payment not to exceed \$1,300,000.00, is authorized to be encumbered with a purchase order and made payable to **Bain Medina Bain, Inc.**, for consultant services.
- c) The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocation to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 4.** This Ordinance shall be effective immediately upon passage by eight or more affirmative votes; otherwise, it shall be effective on the tenth day after passage.
