

AN ORDINANCE 2009-05-21-0409

AUTHORIZING A MEMORANDUM OF UNDER-STANDING WITH THE PORT AUTHORITY OF SAN ANTONIO FOR THE 36TH STREET EXTENSION: US 90 TO GROWDON AND GROWDON TO BILLY MITCHELL PROJECTS, 2004, 2005, AND 2006 CERTIFICATE OF OBLIGATION AND 2007 STREET BOND FUNDED PROJECTS IN COUNCIL DISTRICTS 4 AND 5.

WHEREAS, on March 18, 1999, the City Council approved Ordinance No. 89422 authorizing the City to enter into a contract with HDR, Inc. for professional design services related to the 36th Street: US 90 to Growdon Project; and

WHEREAS, the Greater Kelly Development Authority, which is now known as the Port Authority, had entered into a contract with Civil Engineering Consultants for professional design services related to the 36th Street Extension: Growdon to Billy Mitchell Project; and

WHEREAS, the City and the Port Authority have decided that managing both projects together would provide continuity and provide better accounting of funding strategies; and

WHEREAS, this Ordinance will authorize a Memorandum of Understanding that will provide for the coordination of responsibilities between the City and the Port Authority; and

WHEREAS, approval of this Ordinance will be a continuation of City Council policy to collaborate with other governmental agencies in supporting the City's commitment to maintaining and improving existing infrastructure; **NOW THEREFORE**,


BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:




SECTION 2. There is no financial impact with this Ordinance.
