

AN ORDINANCE 2009-04-09-0272

**ACCEPTING \$194,210.54 FROM THE HAYS STREET BRIDGE  
RESTORATION FUND OF THE SAN ANTONIO AREA FOUNDATION  
FOR THE HAYS STREET BRIDGE REHABILITATION PROJECT.**

**WHEREAS**, the Hays Street Bridge Rehabilitation Project is a revitalization project to restore the Hays Street Bridge and convert it into a pedestrian and biking bridge over the Union Pacific Railroad tracks; and

**WHEREAS**, this Ordinance accepts a donation in the amount of \$194,210.54 from the Hays Street Bridge Restoration Fund of the San Antonio Area Foundation for the Hays Street Bridge Rehabilitation Project; **NOW THEREFORE**,

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The City Manager or her designee is authorized to accept a donation for approximately \$194,210.54 from the Hays Street Bridge Restoration Fund of the San Antonio Area Foundation for the Hays Street Bridge Rehabilitation Project to rehabilitate the Hays Street Bridge and convert it into a pedestrian and biking bridge over the Union Pacific Railroad tracks.


**SECTION 2.** The following financial adjustments are hereby approved:

- a) Funds are authorized to be received from the San Antonio Area Foundation, to SAP Fund 43099000, Certificates of Obligation Capital Projects, SAP Project Definition 50-00108, Hays Street Bridge Rehabilitation, shall be revised by increasing WBS element 50-00108-90-06, entitled Contribution from SA Area Foundation, SAP GL Account 4502280 – Contribution from other Agencies, by the amount of \$194,210.54.
- b) The amount of \$194,210.54 is appropriated in SAP Fund 43099000, Certificates of Obligation Capital Projects, SAP Project Definition 50-00108, Hays Street Bridge Rehabilitation, SAP WBS Element 50-00108-05-02-01-01-01, entitled City Construction Costs, SAP GL Account 5201140.


**SECTION 3.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocation to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 4.** This Ordinance shall take effect on the tenth day after passage.
