

AN ORDINANCE 2015-02-19-0135

AMENDING THE OFFICIAL ZONING MAP OF THE CITY OF SAN ANTONIO BY AMENDING CHAPTER 35, UNIFIED DEVELOPMENT CODE, SECTION 35-304, OF THE CITY CODE OF SAN ANTONIO, TEXAS BY CHANGING THE ZONING DISTRICT BOUNDARY OF CERTAIN PROPERTY.

WHEREAS, a public hearing was held after notice and publication regarding this amendment to the Official Zoning Map at which time parties in interest and citizens were given an opportunity to be heard; and

WHEREAS, the Zoning Commission has submitted a final report to the City Council regarding this amendment to the Official Zoning Map of the City of San Antonio; **NOW THEREFORE,**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Chapter 35, Unified Development Code, Section 35-304, Official Zoning Map, of the City Code of San Antonio, Texas is amended by changing the zoning district boundary of 0.1607 of an acre out of Lots 409 & 410, NCB 11432 from "R-5 AHOD" Residential Single-Family Airport Hazard Overlay District to "R-3" Residential Single-Family Airport Hazard Overlay District.

SECTION 2. A description of the property is attached as **Attachment "A"** and made a part hereof and incorporated herein for all purposes.

SECTION 3. All other provisions of Chapter 35 except those expressly amended by this ordinance shall remain in full force and effect including the penalties for violations as made and provided for in Section 35 -491.


SECTION 4. The Director of Development Services shall change the zoning records and maps in accordance with this ordinance and the same shall be available and open to the public for inspection.

Being 0.1607 Acres (7,000.0 sq. ft.) of land comprised of the south 70.0 ft. of Lots 409 & 410, N.C.B. 11432, Mount Vernon Place Subdivision, recorded in Volume 368, Page 74 of the Deed & Plat Records of Bexar County, Texas and this 0.1607 Acre Tract of land being more particularly described as follows:

Beginning at a ½" dia. iron pin found on the east right of way line of Roanoke Ave. for the northwest corner of the herein described tract and the Point of Beginning bears S. 00° 33' 15" W., 70.00 feet from the southeast intersection corner of Lark Ave. and Roanoke Ave.;

THENCE: S. 89° 46' 39" E., 100.00 feet leaving the east right of way line of Roanoke Ave. across said Lots 409 & 410 and along the north line of this tract, to a ½" dia. iron pin set on the east line of said Lot 409 for the northeast corner of the herein described tract;


THENCE: S. 00° 33' 15" W., 70.00 feet along the east line of said Lot 409, N.C.B. 11432, to a ½" dia. iron pin set for the southeast corner of the herein described tract, said point also being the southeast corner of said Lot 409, N.C.B. 11432;

THENCE: N. 89° 46' 39" W., 100.00 feet along the south line of said Lots 409 & 410, N.C.B. 11432, also being the north line of Lot 433 & 434, N.C.B. 11432 also recorded within said Mount Vernon Place Subdivision, to a ½" dia. iron pin set on the east right of way line of Roanoke Ave., for the southwest corner of the herein described tract, said point also being the southwest corner of said Lot 410, N.C.B. 11432 and the northwest corner of said Lot 433, N.C.B. 11432;

THENCE: N. 00° 33' 15" E., 70.00 feet along the east right of way line of Roanoke Ave., to the Point of Beginning and containing 0.1607 Acres of land more or less.


