**SUPPORTING A PROPOSED AGREEMENT  
BETWEEN CITY PUBLIC SERVICE BOARD OF  
SAN ANTONIO (CPS ENERGY) AND THE  
UNIVERSITY OF TEXAS AT SAN ANTONIO  
(UTSA) TO PROMOTE SUSTAINABLE ENERGY  
TECHNOLOGIES AND RESEARCH**

**WHEREAS**, CPS Energy is a municipally owned utility providing retail gas and electric service to customers of the city of San Antonio, and of Bexar County and neighboring counties; and

**WHEREAS**, UTSA is an institution of higher education and research within the University of Texas System also located in the city of San Antonio and Bexar County, Texas; and

**WHEREAS**, CPS Energy and UTSA are proposing to enter into an agreement that will provide research, education and strategic analysis in sustainable energy technologies and energy research that will benefit the customers of CPS Energy and support the progress of the city of San Antonio and

**WHEREAS**, CPS Energy and UTSA propose that the agreement be for a term ending no later than September 30, 2020; and that the services to be rendered by UTSA under the agreement, be funded by CPS up to and in an amount not to exceed \$50,000,000; **NOW, THEREFORE:**

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The City of San Antonio urges CPS Energy and UTSA to enter into the proposed agreement because it will provide research, education and strategic analysis in sustainable energy technologies and energy research that will benefit the citizens of San Antonio and support the progress of the city of San Antonio, as well as benefiting the customers of CPS Energy; and

**SECTION 2:** The City of San Antonio fully supports the goals and objectives in the proposed agreement between CPS Energy and UTSA.







