SPECIAL MEETING OF THE COMMISSIONERS OF THE CITY OF SAN ANTONIO, HELD IN THE COUNCIL CHAMBER OF THE CITY HALL, AT 4:00 O'CLOCK, P.M., ON WEDNESDAY, AUGUST 14, 1946.




