

AN ORDINANCE **94586**

INCREASING VESTED RIGHTS PERMIT FEE FROM \$145.00 TO \$160.00; INCREASING NOTIFICATION LIST FEE FROM \$50.00 TO \$52.00, INSIDE CITY LIMITS, AND FROM \$100.00 TO \$104.00 OUTSIDE CITY LIMITS; INCREASING PLAN AMENDMENT FEE FROM \$257.50 TO \$268.00 PER PLAN AMENDMENT; INCREASING PLAN COMPLETENESS REVIEW FEE FROM \$381.10 TO \$397.00; AND INCREASING COMPUTER GENERATED MAPS FEE (FOR ALL MAPS INCLUDING ZONING MAPS) FROM \$15.00 PER LINEAR FOOT TO \$18.00 PER LINEAR FOOT.

(Amends City Code-Chapter 35)

WHEREAS, as a part of the overall Fiscal Year 2001-2002 Proposed Budget development process, there has been identified the need to adjust the fees charged by the Planning Department by creating a new fee and increasing existing fees; and

WHEREAS, this ordinance has been coordinated with the Office of Management & Budge Analysis; **NOW THEREFORE**,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Chapter 35 of the Unified Development Code, "Exhibit C. Fee Schedule" is hereby amended in portion by adding the language that is underlined (added) and deleting the language that is stricken (~~deleted~~) to the existing text of said Sections below:

- Section 35-C102(b) entitled "Fees Established" is hereby amended in portion by increasing:

(A) Permit Development Order Document or Action	(B) Fee Amount
Reproduction charges computer generated maps, per linear ft.	\$15.00 <u>\$18.00</u>

- Section 35-C103 entitled “Subdivision and Platting Fees” is hereby amended in portion by increasing the following:

(A) Permit Development Order Document or Action	(B) Fee Amount	
Plan Review Fee, Per Review	\$381.10	<u>\$397.00</u>
Plan Amendment Fee, Per Amendment	\$257.50	<u>\$268.00</u>
Notification List Fee:		
Inside City Limits	\$50.00	<u>\$52.00</u>
Outside City Limits	\$100.00	<u>\$104.00</u>
Development Rights Determination	\$145.00	

- The fees in Section 35-C108 entitled “Vested Rights Determination” is increased from \$145.00 to \$160.00.

SECTION 2. Should any article, section, part, paragraph, sentence, phrase, clause, or word of this Ordinance, or any appendix hereof, for any reason, be held illegal, or invalid, or any exception to or limitation upon any general provision contained in this Ordinance or its attachment held to be unconstitutional or invalid, the remainder shall, nevertheless, stand as effective and as valid as if it had been enacted and ordained without the portion held to be unconstitutional or invalid.

SECTION 3. All other provision of Chapter 35 of the Unified Development Code, “Exhibit C. Fee Schedule” shall remain unchanged and in full force and effect.


SECTION 4. This ordinance shall take effect on the tenth day from the date of passage hereof.
