

AN ORDINANCE **2011-12-15-1034**

AUTHORIZING THE ISSUANCE OF A \$251,068.00 JOB ORDER IN COMMUNITIES PUTTING PREVENTION TO WORK GRANT FUNDS TO ALPHA BUILDING CORPORATION FOR A PLAYGROUND FACILITY ADJACENT TO THE MISSION BRANCH LIBRARY AS PART OF THE MISSION LIBRARY OUTDOOR PLAZA PROJECT.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or her designees are authorized and directed to issue a job order of up to \$251,068.00 to Alpha Building Corporation for playground-related improvements at the Mission Branch library, the specific improvements and their specifications to be determined by the City Manager or her designee in the best interests of the City and the most efficient use of the affected space. The City Manager or her designees should take all actions necessary or convenient to effectuate the transaction, including executing and delivering all necessary or convenient instruments and agreements.

SECTION 2. The amount of \$251,068.00 is appropriated in SAP Fund 2302236001, ARRA CPPW Library, SAP Internal Order # 136000000486, SAP GL account 6102100 – Interfund Transfer out entitled From ARRA - CPPW - Library. The amount of \$251,068.00 is authorized to be transferred to SAP Fund 46097000.

SECTION 3. The budget in SAP Fund 46097000, Hud 108 Projects, SAP Project Definition 40-00234, Mission Library Amphitheater, shall be revised by increasing SAP WBS Element 40-00234-90-02 entitled Transfer from I/O# 136000000486, SAP GL Account 6101100 – Interfund Transfer In, by the amount \$251,068.00.

SECTION 4. The amount of \$251,068.00 is appropriated in SAP Fund 46097000, Hud 108 Projects, SAP Project Definition 40-00234, Mission Library Amphitheater, SAP WBS Element 40-00234-05-02-02, entitled Construction Costs - Playgrounds, SAP GL Account 5201140, and is authorized to be encumbered and made payable to Alpha Building Corporation for construction services.



The Director of Finance may, subject to concurrence by the City Manager, or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal


Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 6. This ordinance is effective immediately upon passage by eight affirmative votes; otherwise it is effective on the tenth day after passage.


