

AN ORDINANCE 2013 - 09 - 19 - 0663

AUTHORIZING THE RENAMING OF “BAMBERGER TRAIL” TO “CHAMPIONS GATE” BETWEEN THE INTERSECTIONS OF NORTH LOOP 1604 WEST AND KYLE SEALE PARKWAY, LOCATED IN CITY COUNCIL DISTRICT 8, SAN ANTONIO, TEXAS.

WHEREAS, an application was submitted by the Northside Independent School District (“NISD”) to change the name of Bamberger Trail, a city road, to Champions Gate between the intersections of North Loop 1604 West and Kyle Seale Parkway; and

WHEREAS, the Development Services Department staff was tasked with implementing this request through the street renaming process as required by the Chapter 6 of the City Code; and

WHEREAS, this request was forwarded to and reviewed by all City of San Antonio Departments and outside agencies and no opposition was identified; and

WHEREAS, staff conducted a technical review finding it to conform to City Code requirements for renaming of public streets; and

WHEREAS, notice of this request to rename said street was properly posted at City Hall, notice was mailed to affected property owners, and notice was disseminated through public service announcements, the notice requirements for renaming of the street has been satisfied in accordance with Chapter 6 of the City Code; and

WHEREAS, a public hearing before the Planning Commission was held on June 26, 2013, where they reviewed evidence and public testimony was welcomed regarding the proposed street name change. No written opposition was received to the name change from affected property owners; and

WHEREAS, the Planning Commission approved a motion to support the street name change of Bamberger Trail to Champions Gate; **NOW THEREFORE**,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The city-owned street known as Bamberger Trail located in City Council District 8 between North Loop 1604 West and Kyle Seale Parkway is hereby renamed Champions Gate. Public Works City staff is directed to provide appropriate signage to this effect.

SECTION 2. Funds generated by this ordinance will be deposited per the table below:

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific Cost Centers, WBS Elements, Internal Orders, General Ledger Accounts, and Fund Numbers as necessary to carry out the purpose of this Ordinance.

SECTION 4. This Ordinance becomes effective immediately upon receipt of eight affirmative votes; otherwise, it becomes effective ten days after passage.






