

A RESOLUTION      **2015-02-19-0013R**

**IN SUPPORT OF BRISTOL POINTE FOR THE 2015 COMPETITIVE 9% HOUSING TAX CREDIT APPLICATION PROCESS AS REQUIRED BY THE TEXAS DEPARTMENT OF HOUSING AND COMMUNITY AFFAIRS.**

**WHEREAS**, Wolfpack Group, LLC, a Texas limited liability corporation (the "Applicant"), has proposed a development for multi-family affordable rental housing to be located in the southwest quadrant of Overlook Parkway and Highway 281 named Bristol Pointe (the "Development"), in the City of San Antonio, County of Bexar; and

**WHEREAS**, the Applicant intends to submit an application to the Texas Department of Housing and Community Affairs (TDHCA) for 2015 Housing Tax Credit Program funds for Bristol Pointe; and

**WHEREAS**, the City of San Antonio has determined there is a need for affordable rental housing units in the proposed Development location; **NOW THEREFORE:**

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The City of San Antonio, County of Bexar, acting through its governing body, hereby confirms that it supports the proposed Bristol Pointe to be located in the southwest quadrant of Overlook Parkway and Highway 281, TDHCA #15225, and that this formal action has been taken to put on record the opinion expressed by the City of San Antonio on February 19, 2015.

**SECTION 2.** The City of San Antonio hereby supports the proposed Bristol Pointe (the "Development") and confirms that its governing body has voted specifically to approve the construction of the Development and to authorize an allocation of Housing Tax Credits for the Development.


