

AN ORDINANCE 2010-06-24-0597

AUTHORIZING AN AMENDMENT IN THE INCREASED AMOUNT OF UP TO \$99,550.00 TO THE \$314,495.00 PROFESSIONAL SERVICES AGREEMENT WITH WESTEAST DESIGN GROUP, LLC FOR ADDITIONAL DESIGN SERVICES FOR THE NEW FIRE STATION #50 PERMANENT FACILITY PROJECT, AN AUTHORIZED CERTIFICATE OF OBLIGATION FUNDED PROJECT, LOCATED IN COUNCIL DISTRICT 4.

WHEREAS, the Fire Station #50 Permanent Facility Project provides permanent facilities to house Fire Department resources in the annexed area on the south side of San Antonio in Council District 4; and

WHEREAS, Ordinance No. 2008-03-13-0192 authorized a professional services agreement with **WestEast Design Group, LLC** for the Fire Station #50 Permanent Facility Project; and

WHEREAS, this Ordinance amends the existing professional services contract with **WestEast Design Group, LLC** in the amount of up to \$99,550.00 to provide additional design services for design and project management services to achieve LEED Silver Certification; and

WHEREAS, this amendment will increase the agreement with **WestEast Design Group, L.L.C.** in the amount of up to \$99,550.00 for a total amount of \$414,045.00; **NOW THEREFORE**,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The professional engineering services contract between the City of San Antonio and **WestEast Design Group, LLC** is amended in the amount of \$99,550.00 for additional design services in connection with the Fire Station #50 Permanent Facility Project.

SECTION 2. The following financial adjustments are hereby authorized to effect this Ordinance:

- a) The budget in SAP Fund 43099000, Certificates of Obligation Capital Projects, SAP Project Definition 20-00110, Fire Station #50 Permanent, and the budget shall be revised by increasing/decreasing SAP WBS Element as follows:

- b) Payment in the amount not to exceed \$99,550.00 in SAP Fund 43099000, Certificates of Obligation Capital Projects, SAP Project Definition 20-00110, Fire Station #50 Permanent, is authorized to be encumbered and made payable to **WestEast Design Group, LLC** for design services.


SECTION 3. The financial allocations in this Ordinance are subject to approval by the Chief Financial Officer, City of San Antonio. The Chief Financial Officer may, subject to concurrence by the City Manager or the City Manager's designee, correct allocation to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 4. This Ordinance shall be effective immediately upon passage by eight or more affirmative votes; otherwise, it shall be effective on the tenth day after passage.


