AN ORDINANCE **77300**

APPOINTING REYNALDO NIETO TO FILL THE
UNEXPIRED CITY COUNCIL TERM OF FRANK D.
WING, WHO HAS RESIGNED, AND DECLARING AN
EMERGENCY.

WHEREAS, Councilman Frank D. Wing, District 4 representative on the City Council, has resigned; and

WHEREAS, pursuant to City Charter Section 8, a vacancy on the Council is to be filled by a majority vote of the remaining members for the unexpired term; and

WHEREAS, the City Council has carefully considered this issue, and it has been determined that Reynaldo Nieto possesses all of the qualifications required for the office, and it is believed he will be an effective and knowledgeable member of this body;
NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. That Reynaldo Nieto is hereby appointed as a member of the City Council, Place No. 4, to serve for the remainder of the unexpired term of Frank D. Wing.

SECTION 2. Because of the citizens of District 4 should not be without representation on the Council, an emergency is declared so that upon receipt of eight affirmative votes, this ordinance and the appointment made hereby shall be effective immediately upon passage hereof.


