IN URBAN RENEWAL PLAN, CIVIC CENTER PROJECT, TEX. R-83.

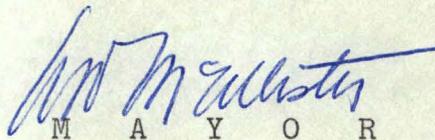
BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

The Urban Renewal Agency of the City of San Antonio is hereby requested to make the following changes in the Urban Renewal Plan, Civic Center Project, Tex. R-83, subject to the concurrence by the United States Department of Housing and Urban Development:

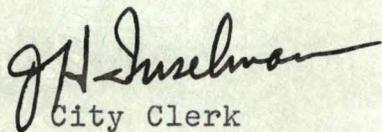
1. Waterway
  - a. Work to be done by Urban Renewal
  - b. Include excavation and bridge for convention center.
  - c. Provide for Marina location
  
2. 200 Block South Alamo
  - a. Provide for clearance of first two lots
  - b. Provide for clearance of other lots if noncompliance by owners:
  
3. Boundary changes
  - a. Enlarge plan to include for public use the two blocks south of La Villita area.
  - b. Dedicate necessary Durango Street right-of-way in this area.
  
4. South Alamo Street
  - a. Include widening of South Alamo Street, Market to Durango area by Urban Renewal
  - b. Dedicate right-of-way as necessary
  
5. Durango Street
  - a. Provide paving to be done by Urban Renewal
  - b. Realign at East end to eliminate institutional tract from plan
  
6. Site changes
  - a. Show Tower Site
  - b. Federal Site
  - c. State site as revised
  - d. Parking arrangements
  - e. Make commercial the area between Market and Commerce Streets East of Public Waterway

7. Water Street
  - a. Change to utility easement
8. Commercial Zone
  - a. Change definitions to permit new hotels
  - b. Site maintenance facilities
9. Market Street
  - a. Dedicate additional right-of-way needed for access street in front of Convention Center
10. Financial Plan
  - a. Provide for long term purchase of site by City
  - b. Revise cash payments plan as necessary in amount and pay over longer period if possible.
11. Any other changes necessary to plan at this time.

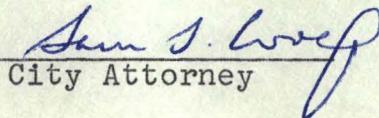
