

AN ORDINANCE 2015-01-08-0002

AUTHORIZING THE SELECTION, NEGOTIATION AND EXECUTION OF A PROFESSIONAL SERVICES AGREEMENT IN THE AMOUNT NOT TO EXCEED \$1,800,000.00 WITH CAMACHO-HERNANDEZ & ASSOCIATES, LLC TO PROVIDE CIVIL ENGINEERING DESIGN SERVICES FOR DEZAVALA-UPRR TO LOCKHILL SELMA, A 2015 CERTIFICATE OF OBLIGATION FUNDED PROJECT LOCATED IN COUNCIL DISTRICT 8.

WHEREAS, this Project provides design of a four lane road with turn lanes at intersections, curbs, sidewalks, driveway approaches, and drainage and traffic signal improvements; and

WHEREAS, this Ordinance authorizes the selection, negotiation and execution of a Professional Services Agreement with **Camacho-Hernandez & Associates, LLC** in an amount not to exceed \$1,800,000.00; and

WHEREAS, this Ordinance only authorizes the design of the De Zavala Road Project and the construction funds will be determined at a later date; and

WHEREAS, approval of this Ordinance will be a continuation of City Council policy to complete previously approved 2015 Certificate of Obligation funded Project **NOW THEREFORE**,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. **Camacho-Hernandez & Associates, LLC** is selected for negotiation and execution of a Professional Services Agreement to provide civil engineering design services for the DeZavala-UPRR to Lockhill Selma Project in Council District 8.

SECTION 2. The City Manager or her designee is authorized to negotiate and execute a Professional Services Agreement in the amount not to exceed \$1,800,000.00.

SECTION 3. The following financial adjustments are hereby approved:


- a) Payment in the amount not-to-exceed \$1,800,000.00 in SAP Fund 40099000, Other Capital Projects, SAP Project Definition 40-00461, De Zavala - UPRR to Lockhill Selma Precon, is authorized to be encumbered and made payable to **Camacho-Hernandez & Associates, LLC.**, for Professional Services. Payments for services are contingent upon the availability of funds and the sale of future City of San Antonio, Certificates of Obligation in accordance with the adopted capital budget. Payment is limited to the amounts budgeted in the Operating and/or Capital Budget funding sources identified. All expenditures will comply with approved operating and/or capital budgets for current and future fiscal years.
- b) The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 4. This Ordinance shall be effective immediately upon passage by eight affirmative votes; otherwise it shall be effective on the tenth day after passage hereof.
