A RESOLUTION

DESIGNATING THE NORTHWEST CORNER OF THE INTERSECTION OF ALAMO AND NUEVA STREETS AS THE SITE TO BE USED IN THE RELOCATION OF THE STRUCTURE KNOWN AS THE GROOS HOME.

WHEREAS, by resolution passed and approved by the City Council on August 25, 1966, the Urban Renewal Agency of the City of San Antonio was requested to dismantle and relocate the Groos Home structure located on Parcel 135 within Civic Center Project TEX R-83 to a new location to be designated by the City Council, and;

WHEREAS, the City Council has determined that the northwest corner of the intersection of Alamo and Nueva Streets is an appropriate site for the relocation of the Groos Home; NOW THEREFORE:

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

That the Urban Renewal Agency is hereby requested to proceed to dismantle and relocate the Groos Home on property situated at the northwest corner of the intersection of Alamo and Nueva Streets.
