

AN ORDINANCE 2014 - 06 - 12 - 0435

AUTHORIZING THE SETTLEMENT OF A LAWSUIT STYLED *MARIA ELENA RODRIGUEZ* v. *CITY OF SAN ANTONIO, ET AL*, CAUSE NUMBER 2012-CI-02394, PENDING IN THE 224TH JUDICIAL DISTRICT COURT, BEXAR COUNTY, TEXAS, FOR PAYMENT IN THE AMOUNT OF \$185,000.00 FROM THE SELF-INSURANCE LIABILITY FUND.

WHEREAS, on March 7, 2010, Maria Elena Rodriguez was a passenger in a private vehicle that had a collision with a San Antonio Police Department vehicle being operated by Sergeant Gabriel Trevino; and

WHEREAS, Ms. Rodriguez has brought suit against the City alleging injuries and other damages as a result of that collision; and

WHEREAS, although the City of San Antonio has vigorously contested liability in this matter, it is in its best interest to settle this matter to avoid the uncertainty and risks associated with further litigation; and

WHEREAS, the parties have reached an agreed settlement of \$185,000.00 to resolve all outstanding claims, contingent upon Council approval; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The amount of \$185,000.00 is authorized to be paid from Fund 75001000, Insurance Reserve Fund and General Ledger 5402530, General Liability Claims and Cost Center 0709020010, TPA Claims, and is authorized to be made payable to the Plaintiff Maria Elena Rodriguez and her attorneys of record as settlement of Cause Number 2012-CI-02394 styled *Maria Elena Rodriguez v. City of San Antonio*.

SECTION 2. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 3. This ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.


