

AN ORDINANCE 2010-03-04-0167

APPOINTING MARSHA L. ELLIS AND REAPPOINTING JOSEPH S. TARTELL AND RONALD B. MARTIN TO THE MUNICIPAL CIVIL SERVICE COMMISSION; SETTING ALL TERMS OF OFFICE TO COMMENCE ON MARCH 4, 2010, AND TO EXPIRE MARCH 3, 2012; AND APPOINTING JOSEPH S. TARTELL AS CHAIRMAN.

WHEREAS, the City Charter provides for the establishment of the Municipal Civil Service Commission, which hears employee disciplinary appeals; and

WHEREAS, the Commission consists of three regular members and three alternates, who are appointed by the City Council for two-year terms;

WHEREAS, in past years, the terms for the Commission have been staggered, requiring Council action to appoint members at varying times of the year; and

WHEREAS, staff recommends that Council realign the terms, so that all Commissioner's terms will expire simultaneously; and

WHEREAS, in an effort to select Commission members, vacancies were advertised through news releases, public service announcements, and on-line bulletin boards, and interviews were conducted by City staff; and

WHEREAS, the recommendations by City staff were presented to the Governance Council Committee on February 17, 2010, which forwarded its slate of candidates for Council consideration; **NOW THEREFORE**:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Marsha L. Ellis (At-Large Commissioner) is appointed, and Joseph S. Tartell (At-Large Commissioner) and Ronald B. Martin (At-Large Commissioner) are appointed to the Municipal Civil Service Commission.

SECTION 2. All terms of office commence on March 4, 2010 and expire March 3, 2012.

SECTION 3. Joseph S. Tartell is appointed Chairman.


SECTION 4. This Ordinance is effective immediately upon the receipt of eight (8) affirmative votes.




