

AN ORDINANCE 2010-06-03-0482

AUTHORIZING THE SUBMISSION OF A GRANT APPLICATION AND THE ACCEPTANCE OF \$225,533.00, UPON AWARD, FROM THE U.S. DEPARTMENT OF JUSTICE, BALLISTIC VEST PARTNERSHIP PROGRAM FOR THE PURCHASE OF ADDITIONAL BALLISTIC VESTS.

WHEREAS, the U.S. Department of Justice has grant funds available in the amount of from the Ballistic Vest Partnership Program for the purchase of ballistic vests for the San Antonio Police Department, the San Antonio Park Police, the San Antonio Airport Police, and the San Antonio Fire Department Arson Unit during the period May 1, 2010, to April 30, 2011; and

WHEREAS, grant funds may be used to pay for fifty percent of the cost of the ballistic vests; and

WHEREAS, the City must pay the remaining fifty percent of the cost of the ballistic vests;
NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager and her designee are hereby authorized to submit a grant application in an amount not to exceed \$225,533.00 to the U.S. Department of Justice Ballistic Vest Partnership Program for the purchase of ballistic vests for the San Antonio Police Department, the San Antonio Park Police, the San Antonio Airport Police, and the San Antonio Fire Department Arson Unit during the period May 1, 2010, to April 30, 2011. The City Manager and her designee are hereby authorized to accept said grant, if awarded under the same terms and conditions as applied for. The City Manager and her designee are further authorized to execute any and all documents necessary to effectuate said application and acceptance.

SECTION 2. Fund 26028000 (Department Of Justice) is hereby designated for use in the accounting for the fiscal transaction in the acceptance of this grant. Should funding be awarded, the sum of \$225,533.00 from the Department of Justice will be appropriated in said fund. A formal final budget shall be submitted upon award. The proposed budget attached hereto as **Exhibit I** is hereby approved.

SECTION 3. The financial allocations in this ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purposes of this ordinance.






