

AN ORDINANCE **94587**

ESTABLISHING A FEE OF \$45.00 FOR THE PURCHASE OF EACH DESIGN CRITERIA MANUAL TO BE PRODUCED BY THE PUBLIC WORKS DEPARTMENT.

(Amends City Code-Chapter 35)

WHEREAS, the Public Works Department will be creating a design criteria manual that will complete and update the June 1989 edition of the Public Works Criteria Design Manual for Developers that sets the standardization and clarification of design criteria of the Public Infrastructure for Land Development with the City limits and Extra Territorial Jurisdiction and will be reviewed and updated each year; and

WHEREAS, a fee of \$45.00 will be established for the Design Criteria Manual; and

WHEREAS, this ordinance will result in an estimated \$4,500.00 annually to the general fund and will help offset the costs of creating the manual, **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Section 35-509 entitled "Criteria Design Manual" of the Unified Development Code is hereby adopted.

SECTION 2. The text of the aforementioned section shall read as follows:

"Section 35-509. Criteria Design Manual.

The Public Works Criteria Design Manual sets forth design criteria for infrastructure and land development with the city limits and extra territorial jurisdiction. This manual shall be available for a fee of \$45.00 per copy."


SECTION 3. This ordinance shall take effect ten days from the date of passage.


