

AN ORDINANCE 2013-09-05-0602

APPOINTING JUAN F. SOLIS, III TO THE PORT AUTHORITY OF SAN ANTONIO FOR THE REMAINDER OF AN UNEXPIRED TERM OF OFFICE TO EXPIRE MAY 31, 2015; AND WAIVING THE RESIDENCY REQUIREMENT OF CITY CODE CHAPTER 2, ARTICLE XI, FOR THIS APPOINTMENT.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Juan F. Solis, III is appointed to the Port Authority of San Antonio for the remainder of an unexpired term of office to expire May 31, 2015.

SECTION 2. The residency requirement of City Code, Chapter 2, Article XI, is waived for this appointment.

SECTION 3. This Ordinance is effective immediately upon the receipt of eight affirmative votes, otherwise, it is effective ten days after passage.


