AN ORDINANCE

AMENDING ORDINANCE NO. 22,843 PASSED AND APPROVED MAY 17, 1956 BY APPOINTING ADDITIONAL AND SUBSTITUTE ELECTION OFFICIALS TO FILL VACANCIES

WHEREAS, the City Council of the City of San Antonio, on May 17, 1956, adopted Ordinance No. 22,843 calling an election on the question of issuance of \$20,885,000 Waterworks Improvement and Extension Revenue Bonds, in which ordinance the officers of the said election were appointed, and

WHEREAS, through a series of circumstances beyond the control of this council, and at that time unforeseeable and not anticipated, certain of these officers will be unable to serve on June 12, 1956, thus creating vacancies in the offices; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:
