

AN ORDINANCE 2009-06-04-0464

**RATIFYING THE ADDITION OF THE ED WHITE MIDDLE SCHOOL AS AN EARLY VOTING SITE, AND AMENDING THE LIST OF EARLY VOTING POLLING LOCATIONS FOR THE RUN-OFF ELECTION ON JUNE 13, 2009, AS APPROVED BY ORDINANCE NO. 2009-05-14-0366.**

**WHEREAS**, the voting sites to be used for the Saturday, June 13, 2009 Run-off Election in City Council Districts 2, 5 and 8 were approved on May 14, 2009; and

**WHEREAS**, for voter consistency, voting sites used in a Run-off Election are typically the same as those used in the Main Election; and

**WHEREAS**, in order to ensure that all voters within City Council Districts 2, 5, and 8 have an equal number of Early Voting sites, the City Clerk made arrangements for the Ed White Middle School to be used as an Early Voting site in City Council District 2; and

**WHEREAS**, as a result of that action, it is necessary to amend **Exhibit A** of Ordinance No. 2009-05-14-0366 to reflect the addition of the Ed White Middle School as an Early Voting site in City Council District 2; **NOW THEREFORE**:

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The action of the City Clerk to provide for the addition of the Ed White Middle school as an Early Voting site in City Council District 2, is ratified.

**SECTION 2.** **Exhibit A** of Ordinance No. 2009-05-14-0366, passed and approved on May 14, 2009, is amended to add the Ed White Middle School to the early voting polling sites for the Run-off Election. The revised **Exhibit A** is attached to and incorporated in this Ordinance for all purposes.




