

AN ORDINANCE 34581

NAMING A SPECIAL CANVASSING BOARD FOR ABSENTEE VOTES CAST IN THE JULY 9, 1966 SPECIAL REFERENDUM ELECTION AND AMENDING SEC. 3 OF ORDINANCE 34413 PROVIDING FOR PRECINCT POLLING PLACES AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The Special Canvassing Board to count and canvass all absentee votes and ballots cast at the July 9, 1966, Special Referendum Election shall consist of the Mayor or the Mayor Pro-Tem, as Presiding Judge, and the City Clerk and Councilman Bremer as Clerks.

SECTION 2. Section 3 of Ordinance No. 34413 is hereby amended by changing the polling place for Precinct 163 from St. Leo's School, 119 Octavia to Hatfield Memorial Church of the Nazarene, 4515 South Flores Street.

SECTION 3. Whereas, an emergency is apparent for the immediate preservation of order, good government and public safety which requires that this ordinance become effective at once; therefore, upon the passage of this ordinance by a vote of at least six members of the Council, it shall be effective from and after the date of its passage as provided for by Charter.
