AN ORDINANCE **78056**

DECLARING THE RESULTS OF THE CANVASS OF
MUNICIPAL RUNOFF ELECTION HELD ON THE 5TH
DAY OF JUNE, 1993.

* * * * *

WHEREAS, the regular municipal election for election of members to the San Antonio City Council was held on May 1, 1993; and

WHEREAS, the City Council canvassed the returns at a special meeting held on May 3, 1993, and passed an ordinance declaring the results of said canvass; and

WHEREAS, as a result of the election, no candidate received a majority of all votes cast by the qualified electors voting for member of Council, Place No. 7, and it was necessary to hold a runoff election in District No. 7; and

WHEREAS, said runoff election was held on June 5, 1993, and the members of the City Council convened in special session on June 7, 1993, to canvass and declare the results thereof; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Council convened on this 7th day of June, 1993, to canvass the returns of the runoff municipal election held on the 5th day of June, 1993, to determine the member of the Council, Place No. 7, of the City of San Antonio for the ensuing term of office of two years.

SECTION 2. The City Council has met to canvass the returns and to declare the results of said election in the manner provided by law, and after considering, determining and canvassing all matters of fact appertaining, we, the City Council of the City of San Antonio, do hereby find and declare the results of the said election to be as follows:

FOR MEMBER OF COUNCIL, PLACE NO. 7

"FOR"	Ramiro Cavazos	6,074 votes
"FOR"	Bob Ross	7,396 votes

SECTION 3. The names of the candidates were submitted and the election was held and conducted and the returns thereof were made, all as required by the City Charter, the laws of this State, and at the runoff election there were cast respectively for each of said candidates the number of votes shown above.

SECTION 4. The City Council having canvassed said returns and having found the above results, by a majority vote of the members of the Council of the City of San Antonio, it is declared that as the result of said runoff election, the elected officer of the City of San Antonio, for Councilmember Place No. 7, for the two years commencing on the 7th day of June, 1993, is as follows:
