

AN ORDINANCE 2010-06-24-0638

**APPROVING THE RENAMING OF BITTERS ROAD BETWEEN THE  
CROSS STREETS OF WETMORE ROAD AND NACOGDOCHES ROAD  
TO THE NEW NAME OF MACARTHUR VIEW.**

**WHEREAS**, Councilman John Clamp submitted a request for consideration of a proposal to rename Bitters Road between the cross streets of Wetmore Road and Nacogdoches Road located in City Council District 10, to MacArthur View; and

**WHEREAS**, the renaming of this section of Bitters Road will assist in eliminating public confusion regarding the location of MacArthur High School and its physical campus; and

**WHEREAS**, notice of said proposal was disseminated through a stakeholder mail-out, public service announcements and postings at City Hall, Council believes that the purpose for and input provided by the City Code procedures for renaming streets has been satisfied; **NOW THEREFORE**,

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The city-owned street known as Bitters Road in City Council District 10 located between the cross streets of Wetmore Road and Nacogdoches Road is hereby renamed MacArthur View. City staff is directed to provide appropriate signage to this effect.


**SECTION 2.** The fiscal impact is estimated at a total cost of \$3,715.06. This will cover the public process fees, postage, cost of manufacturing street name signs, and installation of roadway signs through Public Works. The fees will be covered with a one-time expenditure from District 10's NAMP fund.

**SECTION 3.** This Ordinance shall become effective 10 days after passage, unless it receives the eight votes requisite to immediate effectiveness under San Antonio Municipal Code § 1-15, in which case it becomes effective immediately.




