

AN ORDINANCE 2007-03-29-0346

**APPROVING AN INTERLOCAL AGREEMENT WITH THE UNIVERSITY OF TEXAS AT SAN ANTONIO IN AN AMOUNT UP TO \$70,000.00 FOR A COMPREHENSIVE STUDY ON THE STATUS OF WOMEN IN THE SAN ANTONIO AREA IN ORDER TO INFORM THE MAYOR'S COMMISSION ON THE STATUS OF WOMEN AND THE COMMUNITY FOR THE PERIOD ENDING DECEMBER 31, 2007.**

**WHEREAS**, the Mayor's Commission on the Status of Women (MCSW) focuses primarily on providing information on matters that directly affect current employment opportunities, education, social, civic, and political participation by women in San Antonio; and

**WHEREAS**, the MCSW proposed to commission a study on the status of women in the San Antonio area in order to inform policy makers, funding agencies, advocates and service providers in planning their efforts; and

**WHEREAS**, the study will provide information such as demographics, economics and employment, education and training, health, crime and safety, literacy, homelessness, public benefits, and child care situations; and

**WHEREAS**, it is the City's desire to enter into a contract in an amount not to exceed \$70,000.00 with the University of Texas at San Antonio for said study; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The City Manager, or her designee, or the Director of the Department of Community Initiatives, or his designee, is authorized to execute a contract in an amount not to exceed \$70,000.00 with the University of Texas at San Antonio (UTSA) for a comprehensive study on the status of women in the San Antonio area. If an agreement, as first reviewed and approved by the City Attorney, is not signed by both parties within sixty (60) days from the effective date of this ordinance, it becomes null and void, and any further signed documents must be considered by the City Council.

**SECTION 2.** Funding for this ordinance is available in Fund 11001000 General Fund, General Ledger 5201040, Fees to Professional Contractors, in the Cost Centers and amounts listed below as part of the FY07 Budget. Additional funding is contingent upon donations provided by the Mayor's Commission on the Status of Women.


**SECTION 3.** Payment not to exceed \$56,750.00 is authorized to The University of Texas at San Antonio (UTSA) and should be encumbered with a purchase order. The balance of the \$70,000.00 contract is authorized to be paid to UTSA, contingent upon funding availability, and should be encumbered with a purchase order.

**SECTION 4.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 5.** This ordinance shall be effective on and after April 8, 2007.
