

AN ORDINANCE **62057**

APPOINTING THOMAS WEIR LABATT, III, TO FILL THE UNEXPIRED TERM OF VAN HENRY ARCHER, COUNCILMAN FROM DISTRICT 9, WHO HAS RESIGNED.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The resignation of Van Henry Archer as Council member from District 9, effective January 2, 1986, is hereby accepted.

SECTION 2. Thomas Weir Labatt, III, is hereby appointed as a member of the City Council, Place No. 9, to serve for the remainder of the unexpired term of Van Henry Archer.

SECTION 3. Because the citizens of District 9 should not be without representation on the Council, an emergency is declared so that this ordinance and the appointment made hereby shall be effective January 2, 1986.
