

AN ORDINANCE 2012-10-11-0799

**AUTHORIZING A CONTRACT WITH CLEANING IDEAS CORPORATION D/B/A SANIVAC/DAVIS MANUFACTURING FOR FOOD SERVICE SUPPLIES FOR THE SENIOR SERVICES DIVISION OF THE DEPARTMENT OF HUMAN SERVICES FOR AN ESTIMATED ANNUAL COST OF \$94,000.00.**

**WHEREAS**, bids were submitted to provide the City of San Antonio Department of Human Services with food service supplies; and

**WHEREAS**, the bid(s) submitted by All American Poly and Central Poly Corp failed to meet the City's specifications and/or requirements; and

**WHEREAS**, Cleaning Ideas Corporation d/b/a Sanivac/Davis Manufacturing was the low responsive bidder for a cost of \$94,000.00; **NOW THEREFORE**:

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The bid from Cleaning Ideas Corporation d/b/a Sanivac/Davis Manufacturing for food service supplies for an estimated annual cost of \$94,000.00 is hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements. The bid tabulation sheet is attached hereto and incorporated herein for all purposes as **Exhibit I**. Copies of the bids are available for inspection in the offices of the Purchasing & General Services Division of the Finance Department.

**SECTION 2.** It has been found and declared that the low bids of All American Poly and Central Poly Corp failed to meet the City's specifications and/or requirements.

**SECTION 3.** The amount will be encumbered upon issuance of a purchase order, and payment is authorized to Cleaning Ideas Corporation d/b/a Sanivac/Davis Manufacturing. All current fiscal year expenditures will be in accordance with the Fiscal Year 2013 budget approved by City Council, and future fiscal year expenditures are contingent upon future City Council budget approvals.

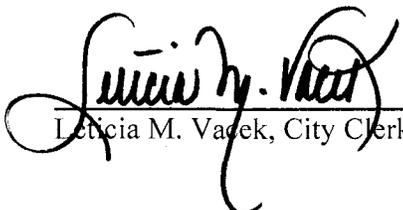
**SECTION 4.** This ordinance is effective immediately upon passage by eight affirmative votes; otherwise it is effective on the tenth day after passage hereof.

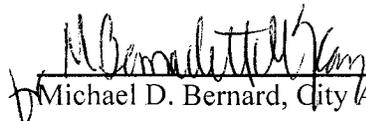

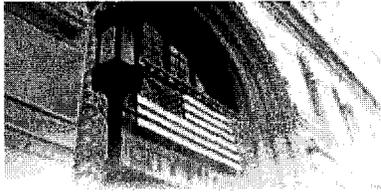

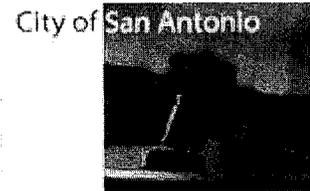
