WOLFE (AT-LARGE, CATEGORY: TAXI CAB INDUSTRY), MARCO A. BARROS (AT-LARGE, CATEGORY: TRAVEL AND TOURISM INDUSTRY), BARBARA L. LOOMIS (AT-LARGE, CATEGORY: COMMUNITY), AND APPOINTING JAMES D. QUINN (AT-LARGE, CATEGORY: BUSINESS COMMUNITY), MICHAEL J. KEYWORTH (AT-LARGE, CATEGORY: FAA), LESLIE A. HOBGOOD (AT-LARGE, CATEGORY: COMMUNITY), AND KYLE M. TATE (AT-LARGE, CATEGORY: COMMUNITY) TO THE AIRPORT ADVISORY COMMISSION FOR THE REMAINDER OF UNEXPIRED TERMS OF OFFICE TO EXPIRE MARCH 18, 2012 AND WAIVING THE RESIDENCY REQUIREMENT IN SECTION 2-529 (B) OF THE CITY CODE FOR GLORIA C. ARRIAGA AND KYLE A. GISH.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Gloria C. Arriaga (At-large, Category: AACOG), Kyle A. Gish (At-large, Category: Aviation Industry), Neil H. Stone (At-large, Category: Business Community), Michael K. Wolfe (At-large, Category: Taxi Cab Industry), Marco A. Barros (At-large, Category: Travel and Tourism Industry), and Barbara L. Loomis (At-large, Category: Community) are reappointed, and James D. Quinn (At-large, Category: Business Community), Michael J. Keyworth (At-large, Category: FAA), Leslie A. Hobgood (At-large, Category: Community), and Kyle M. Tate (At-large, Category: Community) are appointed to the Airport Advisory Commission for the remainder of unexpired terms of office to expire March 18, 2012

SECTION 2. The residency requirement in Section 2-529 (b) of the City Code is waived for the reappointments of Gloria C. Arriaga and Kyle A. Gish.

SECTION 3. This Ordinance is effective immediately upon the receipt of eight (8) affirmative votes, or in the event eight affirmative votes are not received, on the tenth day after passage.




