

AN ORDINANCE 2007-06-28-0737

DESIGNATING EACH MEMBER OF THE CITY COUNCIL AS MAYOR PRO TEM FOR A SPECIFIED PERIOD DURING THE 2007-2009 TERM.

* * * * *

WHEREAS, Section 9 of the Charter of the City of San Antonio provides, in part, for a Mayor Pro Tem to act as Mayor during the absence or disability of the Mayor; and

WHEREAS, a tradition has been established of rotating the Mayor Pro Tem position among all of the members of the Council, other than the Mayor, during the two-year City Council term; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The following named members of the City Council are designated as Mayor Pro Tem of the City of San Antonio to serve during the periods indicated below:

June 28, 2007 through September 7, 2007	Kevin Wolff
September 8, 2007 through November 18, 2007	Diane G. Cibrian
November 19, 2007 through January 29, 2008	Lourdes Galvan
January 30, 2008 through April 10, 2008	Mary Alice P. Cisneros
April 11, 2008 through June 21, 2008	Sheila D. McNeil
June 22, 2008 through September 1, 2008	Philip A. Cortez
September 2, 2008 through November 12, 2008	Justin Rodriguez
November 13, 2008 through January 23, 2009	Delicia Herrera
January 24, 2009 through April 5, 2009	Roland Gutierrez
April 6, 2009 through May 31, 2009, or until such time as said City Councilmember's successor is elected and qualified for office.	John G. Clamp

SECTION 2. Councilmember Kevin Wolff, District 9, is sworn in as Mayor Pro Tem for the period beginning June 28, 2007 through September 7, 2007.

SECTION 3. Should a vacancy in the position of a Councilmember occur during the 2007-2009 Council term, the person appointed to fill the remainder of that vacant position shall assume the vacated Councilmember's designated term as Mayor Pro Tem.




