

AN ORDINANCE **69555**

DESIGNATING CERTAIN MEMBERS OF THE COUNCIL AS
MAYOR PRO TEM FOR SPECIFIED PERIODS OF TIME
THROUGH MAY 31, 1991.

* * * * *

WHEREAS, the City Charter in Section 9, calls for a Mayor Pro Tem to act as mayor during the absence or disability of the Mayor; and

WHEREAS, a tradition has been established of rotating the Mayor Pro Tem position among all of the members of the Council during each two year term; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The following named members of the City Council are hereby designated as Mayor Pro Tem of the City of San Antonio to serve during the periods indicated below:

- June 1, 1989 through August 12, 1989--James Hasslocher
- August 13, 1989 through October 24, 1989--Bob Thompson
- October 25, 1989 through January 5, 1990--Helen Dutmer
- January 6, 1990 through March 20, 1990--Weir Labatt III
- March 21, 1990 through June 1, 1990--Maria Antonietta Berriozabal
- June 2, 1990 through August 13, 1990--Joe Webb
- August 14, 1990 through October 25, 1990--Yolanda Vera
- October 26, 1990 through January 6, 1991--Walter Martinez
- January 7, 1991 through March 20, 1991--Frank Wing
- March 21, 1991 through May 31, 1991--Nelson Wolff

SECTION 2. Should any of the above Council Members be replaced for any reason, such replacement shall be substituted for such member for the term indicated.

SECTION 3. Because of the necessity of having a Mayor Pro Tem to act in the absence of the Mayor, an emergency is hereby declared so that upon receipt of eight affirmative votes this ordinance shall take effect immediately upon passage.


Council members, on the first Council meeting after their new terms of office begin, draw for the dates they will serve as Mayor Pro Tem for the new two-year terms.


