BE IT ORDAINED BY THE COMMISSIONERS OF THE CITY OF SAN ANTONIO:-

1. That \$1786.20 be and the same is hereby appropriated out of the 1946 General Fund - Elections Department, in payment to Talley Transfer Cpmpany for transportation of 200 voting machines from the basement of Court House to various precincts and return, for the City Run-off Election, held in the City of San Antonio on the 27th day of May, 1947, at \$8.70 per machine, \$1740.00; Federal tax, \$46.20, making a total of \$1786.20, as per itemized statement on file in the office of the City Auditor, according to contract dated May 16, 1947.
