BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Section 204, of the Uniform Building Code is hereby amended to provide for the expansion of the Board of Examiners and Appeals from five to eleven members.
