BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:-

1. Ordinance No. 27565, passed and approved May 11, 1959, entitled "Ordinance calling an election to be held in the City of San Antonio on May 30, 1959, on the proposition of the issuance of \$2,150,000.00 New Police Headquarters Building Bonds" is hereby repealed. Said election shall not be held and no votes purportedly cast in the election called for by such repealed ordinance shall be canvassed.

2. WHEREAS, an emergency is apparent for the immediate preservation of order, good government and public safety that requires this ordinance to become effective at once; therefore, upon the passage of this ordinance by a vote of at least six (6) members of the Council, it shall be effective from and after the date of its passage as made and provided by the Charter of the City of San Antonio.




