

SPECIAL MEETING OF THE CITY COUNCIL
OF THE CITY OF SAN ANTONIO HELD IN
THE COUNCIL CHAMBER, CITY HALL, ON
MONDAY, APRIL 23, 1979.

The meeting was called to order at 1:30 P.M., by the presiding officer, Mayor Lila Cockrell with the following members present: CISNEROS, WEBB, DUTMER, WING, EURESTE, ALDERETE, MCDANIEL, STEEN, COCKRELL; Absent: ORTIZ, PYNDUS.

79-20 Mayor Cockrell announced that the Special Meeting had been called for the purpose of canvassing the returns of the April 21, 1979 Run-off Election.

Mayor Cockrell and the City Council then proceeded to canvass the returns of the election.

After the canvass was completed and no errors being found, the Clerk proceeded to read the following Ordinance:

AN ORDINANCE 50,638

DECLARING THE RESULTS OF THE CANVASS OF THE
MUNICIPAL RUN-OFF ELECTION HELD ON THE 21ST
DAY OF APRIL, 1979.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Council convened on this 23rd day of April, 1979, to canvass the returns of the run-off municipal election held on the 21st day of April, 1979, to determine the member of the Council, Place No. 3, of the City of San Antonio for the ensuing term of office of two years.

SECTION 2. The City Council has met to canvass the returns and to declare the results of said election in the manner provided by law, and after considering, determining and canvassing all matters of fact appertaining, we, the City Council of the City of San Antonio, do hereby find and declare the results of the said election to be tabulated as follows:

FOR MEMBER OF COUNCIL, PLACE NO. 3:

"FOR" Bob Billa	<u>3,311</u>	votes
"FOR" Helen Dutmer	<u>4,242</u>	votes

SECTION 3. The names of the candidates were submitted and the election was held and conducted and the returns thereof were made, all as required by the City Charter, the laws of the State of Texas and the proclamation of the Mayor, and at said run-off election there were cast respectively for each of said candidates the number of votes shown above.

SECTION 4. The City Council having canvassed said returns and having found the same in all things correct, the canvass was thereupon adopted by a majority vote of the members of the Council of the City of San Antonio, and it is declared that as the result of said runoff election, the elected officer of the City of San Antonio, for Council Place No. 3, for the two years commencing on the 1st day of May, 1979, is as follows:

Member of Council, Place 3: Helen Dutmer
