Purchasing Agent Al Tripp explained the bids received and recommended the low qualified bid of Jim Dulaney Machinery Company be accepted.

Mr. Bob Dulaney, representing Dulaney Service Company, protested the recommendation stating that the low bid of Jim Dulaney Machinery Company did not meet specifications because his literature provided for a 250 gallon water tank while the specifications called for a 275 gallon water tank. He also stated that Item 8 called for the sweeper brooms to be powered through a two-speed power take-off with reverse three wheel. He stated none of the bidders could meet those specifications. Also the literature of the low bidder did not state that the sweeper drive chains are shielded and enclosed and to his knowledge were not.

Mrs. R. T. Dulaney, of Dulaney Service Company, mentioned that on a previous occasion on almost identical circumstances on a Crane sweeper, the literature submitted with the bid did not meet specifications and their bid was thrown out.

The Purchasing Agent stated the low bidder had submitted a letter with his bid stating that all specifications will be met and therefore his bid was in order. He added that the equipment would not be accepted on delivery if it did not meet the specifications.

After discussion it was determined that the specifications on Item 8, which called for a power take-off with reverse "Three" wheel, was a typographical error and should have read a "free" wheel, and all bidders understood and had bid accordingly. As to the water tank capacity and shielding of chain drivers, and other items the low bidder, through his bid, has committed himself to meet the specifications and had met the City's bidding procedure. After further discussion with Mr. Bob Dulaney, and Mrs. R. T. Dulaney, Mr. Gatti, made a motion that the ordinance accepting the low qualified bid of Jim Dulaney Machinery Company be accepted. Seconded by Mr. de la Garza, the ordinance was passed and approved by the following vote: AYES: McAllister, de la Garza, Jones, Kaufman, Cockrell, Gatti, Padilla, Parker and Bremer; NAYS: None; ABSENT: None.

Mr. Martin presented the Council with copies of a resolution of the Urban Renewal Agency approving an amendment of the Urban Renewal Plan, dated February 16th, for Central West Area Project I, Tex. R-39 so that the restrictions pertaining to the coverage of land by buildings on Parcel 18, also known as Parcel 2, NCB 13418, are changed from 10% to 50%.

Mr. Martin explained the Council has approved sale of the property to the County but they have not been able to close the sale because the 10% building restriction is for a 50 year period and is excessive for this parcel. This change has been approved by the Housing and Home Finance Agency pending action by the Urban Renewal Agency and the City Council. Mr. Martin asked the Council to approve the change.

The proposed change was agreeable to the Council, and the City Manager was asked to prepare an ordinance for consideration by the Council.

After a short recess, the meeting reconvened.

City Manager Shelley explained an ordinance making a contract for engineering services, plans and specifications for swimming pools to be located at Monterey Park, Hi-Lions Park, Lincoln Park and Cassiano Park.


