

AN ORDINANCE 2010-08-19-0718

RESCHEDULING CITY COUNCIL MEETINGS IN NOVEMBER AND DECEMBER 2010, AND JANUARY 2011.

* * * * *

WHEREAS, a special election has been called for November 2, 2010, to extend the current 1/8th sales tax for the Edwards and Creekways Programs, and it is necessary to schedule a meeting to canvass the election results for Wednesday, November 10, 2010; and

WHEREAS, Veteran's Day, a national holiday, falls on Thursday, November 11, 2010, and it is necessary to reschedule the City Council meeting of that date to November 18, 2010; and

WHEREAS, the National League of Cities conference falls on the first scheduled City Council meeting days in December 2010, and the City has scheduled a winter break which includes the scheduled City Council meeting days in late December 2010 and early January 2011; and

WHEREAS, traditionally, the A the B Sessions of the City Council and the Council Committee meetings have been rescheduled in order to permit City Council members and City staff to observe holidays as well as to attend the National League of Cities conference, the purpose of which is to identify and address urban issues at state and national levels, for leadership development opportunities and in various constituency groups for policy formulation and program activities; and

WHEREAS, for these reasons, the City Council of the City of San Antonio wishes to reschedule the City Council meetings of November 11, 2010 to November 18, 2010; December 1-2, 2010, to December 8-9, 2010; and December 28-29, 2010, and January 6-7, 2011, to January 12-13, 2011; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. A meeting to canvass the November 2, 2010 election results is scheduled for Wednesday, November 10, 2010.

SECTION 2. The previously scheduled City Council meetings are rescheduled as follows:




In addition, all Council Committee meetings scheduled for the weeks of the previously scheduled Council meetings are rescheduled to the corresponding weeks as noted above.


