
APPROPRIATING \$1786.20 IN PAYMENT TO TALLEY

BE IT ORDAINED BY THE COMMISSIONERS OF THE CITY OF SAN ANTONIO:-


1. That \$1786.20 be and the same is hereby appropriated out
of the 1946 General Fund - Elections Department, in payment to Talley
Transfer Company for transportation of 200 voting machines from the
basement of Court House to various precincts and return, for the
General City Election held in the City of San Antonio on the 13th day
of May, 1947, at \$7.70 per machine, \$1540.00; Federal tax, \$46.20;
and furnishing materials and labor for wiring and plugging in of
said machines, at \$1.00 per machine, \$200.00; making a total of
\$1786.20, as per itemized statement on file in the office of the City
Auditor, according to contract dated April 18th, 1947.
