

A RESOLUTION

REQUESTING THE HONORABLE C. K. QUIN, JUDGE OF THE 57TH DISTRICT COURT, BEXAR COUNTY, TEXAS, AND HONORABLE CHARLES W. ANDERSON, BEXAR COUNTY JUDGE, TO BE PRESENT AND WITNESS THE RE-CHECKING AND COMPARISON BY THE CANVASSING BOARD OF THE OFFICIAL RETURNS OF THE JANUARY 23, 1954 "IMPROVEMENT DISTRICT A" BOND ELECTION WITH THE RESULTS APPEARING AND REGISTERED ON THE VOTING MACHINES USED THEREFOR.


WHEREAS, a written petition bearing the signatures of over twenty-five qualified voters and resident citizens of "Improvement District A" within the city limits of the City of San Antonio, has been filed with the City Council of the City of San Antonio, acting in its official capacity as the canvassing board charged with the duty of canvassing the returns of the special bond election of January 23, 1954, held in said "Improvement District A" requesting said Board to re-check and compare the official election results with the results appearing and registered on the voting machines used in said election; and,


WHEREAS, said petition has been examined and officially accepted by the Canvassing Board; and,

WHEREAS, under the provisions of Section 19, Article 7.14 of the New Election Code, Vernon's Civil Statutes of the State of Texas, such re-check and comparison of the official election returns with the results reflected on the voting machines used in said bond election by the Canvassing Board shall be made in the presence of a District Judge and County Judge of the county in which said election was held; NOW, THEREFORE:-

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:-

1. That the Honorable C. K. Quin, Judge of the 57th District Court, Bexar County, Texas, and Honorable Charles W. Anderson, Bexar County Judge, are hereby respectfully requested by the City Council of the City of San Antonio, acting as a Canvassing Board, to be present and witness a re-check and comparison of the results shown on the official returns now in the process of being canvassed, with the results appearing and registered on the counter dials of each voting machine used in the special bond election held in "Improvement District A" within the bounds and limits of the City of San Antonio on Saturday, the 23rd day of January, A.D. 1954.
2. That the City Clerk is hereby directed to forward a certified copy of this Resolution to the above named officials and to inform them as to the date, time and place said re-check will be made.
