WHEREAS, San Antonio DMA Housing, LLC has proposed a 136 unit affordable rental housing development located at 8130 W. Hausman Road in Council District 8 named Bandera Flats, in the City of San Antonio, County of Bexar; and

WHEREAS, San Antonio DMA Housing, LLC has advised that it intends to submit an application to the Texas Department of Housing and Community Affairs (TDHCA) for 2014 Competitive 9% Housing Tax Credits for the Bandera Flats development; and

WHEREAS, it is necessary for the City to support the proposed Bandera Flats development;
NOW THEREFORE:

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. It is hereby confirmed that the City supports the proposed Bandera Flats development located at 8130 W. Hausman Road in the City of San Antonio, and that this formal action has been taken to put on record the opinion expressed by the City of San Antonio on March 20, 2014.




