

AN ORDINANCE 2014 - 05 - 15 - 0340

**AUTHORIZING THE EXTENSION OF LINE-OF-DUTY  
LEAVE FOR FIRE ENGINEER EDDIE DOUGLAS III.**

**WHEREAS**, section 143.073 of the Texas Local Government Code provides that a firefighter injured in the line of duty is entitled to line-of-duty injury leave with full pay for a period commensurate with the injury and not to exceed one year; and

**WHEREAS**, section 143.073 also provides that a municipality's governing body may extend the line-of-duty injury leave beyond one year; and

**WHEREAS**, San Antonio Fire Department Engineer Eddie Douglas III was injured in the line of duty on May 30, 2012, and, as a result, required leave in excess of one year to address said injury; and

**WHEREAS**, Engineer Douglas is requesting an extension of line-of-duty injury leave beyond one year for the period May 31, 2013, to November 13, 2013; and

**WHEREAS**, approving the requested extension will restore 1,344 hours of accrued leave to Engineer Douglas; **NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** An extension beyond one year of San Antonio Fire Department Engineer Eddie Douglas III line-of-duty injury leave for the period May 31, 2013, to November 13, 2013, is hereby approved.

**SECTION 2.** This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
