

AN ORDINANCE **47842**

DECLARING THE RESULTS OF THE CANVASS OF
THE MUNICIPAL ELECTION HELD THE 2ND DAY
OF APRIL, 1977, IN THE CITY OF SAN ANTONIO,
AND ORDERING A RUN-OFF ELECTION TO BE HELD
THE 16TH DAY OF APRIL, 1977.

WHEREAS, the regular municipal election was held on the 2nd day of April, 1977, to determine the Mayor and Council Members of the City of San Antonio for the ensuing term of office of two years; and

WHEREAS, the names of the candidates were submitted, the election was held and conducted and the returns thereof were made, all as required by the City Charter, the laws of the State of Texas, the proclamation of the Mayor and the law for such cases made and decided; and

WHEREAS, the City Council met on April 4, 1977, in the Council Chamber at City Hall to canvass the returns of said election; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Council having convened April 4, 1977, to canvass the returns of the regular City election held April 2, 1977, after canvassing the returns of said election, the City Council does hereby find and declare the result of the election to be as follows:

SECTION 2. It is further declared that as a result of said election, the following persons were elected Council Members for a two-year term commencing May 1, 1977:

- Henry G. Cisneros, Member of Council, Place No. 1
- Phil Pyndus, Member of Council, Place No. 8
- Glen Hartman, Member of Council, Place No. 9
- John Steen, Member of Council, Place No. 10

and each of them was elected by receiving a majority of all the votes cast for the office for which each was a candidate cast by the qualified voters of the City of San Antonio voting at said election, and they and each of them are hereby declared to be the lawful and duly elected Council Members of the City for the places specified.

SECTION 3. It is further declared that as a result of said election, no candidate for Places No. 2, 3, 4, 5, 6, 7 and 11 (Mayor) received a majority of all the votes for the office for which he was a candidate cast by the qualified voters of the City voting in said election, and therefore, no candidate was elected at said election for the office of Member of Council for Places No. 2, 3, 4, 5, 6, 7 and 11 (Mayor), but that a second or run-off election will be necessary in order that the candidate receiving the highest number of votes shall have received a majority of all the votes cast for the office for which he was a candidate, and said run-off election is hereby ordered to be held on April 16, 1977. The two candidates receiving the highest number of votes for any such place in the election shall again be voted for at the second of run-off election.

SECTION 4. Payment of all expenses incurred in connection with the holding of said election and run-off election is hereby authorized to be made out of the General Fund.
