

A RESOLUTION

APPROVING THE CREATION OF A SISTER CITY
AFFILIATION BETWEEN THE CITY OF SAN
ANTONIO AND THE CITY OF SANTA CRUZ DE
TENEREFE, AND AUTHORIZING THE MAYOR TO
TAKE THE NECESSARY STEPS TO EFFECTUATE
THE AFFILIATION PROGRAM.

WHEREAS, "The People to People Program" was inaugurated by the President of the United States in 1956 to establish greater friendship and understanding between the peoples of the United States and other Nations through Sister City Affiliation, a medium of direct, personal contact; and

WHEREAS, the City of San Antonio, Texas and the City of Santa Cruz De Tenerefe in the Canary Islands have common bonds in that the first settlers of San Antonio were families from these islands, whose language, customs and Christian Traditions still constitute a part of our present day life; and

WHEREAS, it is the desire of the City of San Antonio to enter into a Sister City Affiliation with the City of Santa Cruz De Tenerefe; NOW THEREFORE:

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The formation of a Sister City Affiliation between the City of San Antonio and the City of Santa Cruz De Tenerefe is hereby approved.

SECTION 2. The Mayor is hereby authorized to act as the official representative of the City to carry out the intent of this Resolution.

SECTION 3. That copies of this Resolution be sent to the Hon. Javier Jimenez Ugarte, Consul General of Spain in Houston, Texas, to officially convey to the Mayor and Municipal Government of the City of Santa Cruz De Tenerefe, San Antonio's desire to enter into a Sister City Affiliation.
