AMENDING ORDINANCE NO. 85569 OF FEBRUARY 6, 1997, WHICH ADOPTED POLLING LOCATIONS FOR THE MAY 3, 1997, JOINT AND SPECIAL CHARTER REVISION ELECTION TO REFLECT CHANGES TO THE POLLING LOCATIONS FOR PRECINCTS 2043, 3017, 3141, 3019, 3164, AND A NAME CHANGE FOR THE POLLING LOCATION FOR PRECINCT 4028.

WHEREAS, Ordinance No. 85569 passed and approved on February 6, 1997, adopted polling locations for the May 3, 1997, Joint and Special Charter Revision Election; and

WHEREAS, it is now necessary to amend that ordinance to change the polling locations for Precincts 2043, 3017, 3141, 3019 and 3164, and to reflect a name change for polling location for Precinct 4028; **NOW THEREFORE**:


BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:



SUMMARY:

This ordinance amends Ordinance No. 85569 of February 6, 1997, which adopted polling locations for the May 3, 1997 Joint and Charter Revision Election.

BACKGROUND:

For Precinct 2043, The Highway 90 WIC Clinic has been relocated to 911 Castroville Rd. placing it in a different precinct. Therefore, we will be using Stafford Elementary as we did in the 1995 election.

For Precinct 3017 & 3141, YMCA previously granted us permission to use the facility. However, due to a volleyball tournament set for May 3, our request was denied due to anticipated parking problems. Therefore, we will be using SAM's Club.

For Precinct 3019, Leon Valley Elementary was selected as a polling site(combined with precinct 3033). However, Northside ISD has now advised us that Precinct 3033 is not included in this year's school election. Therefore, Precinct 3019 will be recombined with Precinct 3015, at Glen Oaks Elementary.


For Precinct 3164, it was previously a split precinct in District 8. Due to annexation it is now a complete precinct in District 9. We will be using Fire Station #43 as the polling site.


FINANCIAL IMPACT:

The only impact to the Election Budget will be the charge of approximately \$150 to utilize Stafford Elementary. There are no other differences in costs with the other precincts.

SUMMARY OF ORDINANCE

This ordinance will amend Ordinance No. 85569 of February 6, 1997 to reflect changes to polling places to be used in the May 3, 1997 Joint and Charter Revision Election.

There have been some recent changes which necessitate the amending of the previous Ordinance (No. 85569) as follows:

For 2043: Highway 90 WIC Clinic was relocated to 911 Castroville Rd., placing it in a different precinct. Therefore, we will be using Stafford Elementary as we did in the 1995 Election.

For 3017 & 3141: YMCA previously granted us permission to use the facility. However, due to a volleyball tournament set for May 3, our request was denied due to anticipated parking problems. Therefore, we will be using SAM's Club.

For 3019: Leon Valley Elementary was selected as polling site combined with precinct 3033. However, Northside ISD now advises us that precinct 3033 is not included in this year's election. Therefore, precinct 3019 is recombined with precinct 3015 at Glen Oaks Elem.

For 3164: previously a split precinct in District 8. Due to annexation it is now a complete precinct in District 9. We will be using Fire Station #43 as the polling site.
