

AN ORDINANCE 2014 - 10 - 02 - 0748

**AUTHORIZING THE NAMING OF AN UNNAMED ALLEY TO
"PAPA BEAR LANE" BETWEEN FRESNO STREET AND SANTA
MONICA STREET IN CITY COUNCIL DISTRICT 1, SAN
ANTONIO, TEXAS.**

WHEREAS, the Development Services Department received a request from Dr. Sylvester Perez, Superintendent of San Antonio Independent School District through City Councilman Bernal to name the alley neighboring Edison High School between Fresno Street and Santa Monica Street "Papa Bear Lane" on behalf of the Edison Class of 2014, considering this a lasting memorial to Edison High School and to honor longtime principal Charles Muñoz; and

WHEREAS, the Development Services Department staff was tasked with implementing this request through the street naming process as required by Chapter 6 of the City Code; and

WHEREAS, this request was forwarded to and reviewed by all City of San Antonio departments and outside agencies and no opposition was identified; and

WHEREAS, staff conducted a technical review finding it to conform to City Code requirements for naming of public streets; and

WHEREAS, notice of this request to rename said street was properly posted and mailed to affected property owners, notice requirements for renaming of the street has been satisfied in accordance with Chapter 6 of the City Code and further, no written opposition has been received to the name change from affected property owners; and

WHEREAS, a public hearing before the Planning Commission was held on August 27, 2014 allowing all interested persons to be heard; and

WHEREAS, the Planning Commission approved a motion to support the street name to "Papa Bear Lane;" **NOW THEREFORE**,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:


SECTION 1. The unnamed city-owned alley located in City Council District 1 between Fresno Street and Santa Monica Street is hereby named Papa Bear Lane. The location is more specifically depicted in Attachment 1. City staff is directed to provide appropriate signage to this effect.

SECTION 2. There is no fiscal impact regarding this item.

SECTION 3. This ordinance is effective immediately upon receipt of eight affirmative votes; otherwise, it is effective 10 days after passage.


