

A RESOLUTION
NO. 83-26-61

OF THE CITY COUNCIL OF THE CITY OF SAN ANTONIO, TEXAS, APPROVING THE CREATION OF A SISTER CITY AFFILIATION BETWEEN THE CITY OF SAN ANTONIO AND THE CITY OF MAZATLAN, SINALOA, MEXICO, AND AUTHORIZING THE MAYOR TO TAKE THE NECESSARY STEPS TO EFFECTUATE THE AFFILIATION PROGRAM.

- WHEREAS, "the People to People Program" was inaugurated by the President of the United States in 1956 to establish greater friendship and understanding between the peoples of the United States and other nations through Sister City Affiliation, a medium of direct, personal contact, and
- WHEREAS, Mazatlan is one of the most dynamic and progressive port cities in Mexico, and
- WHEREAS, it is the desire of the Mazatlán Municipal Government and the City Council of the City of San Antonio to further enhance the mutual friendship which exists by the designation of San Antonio and Mazatlán as Sister Cities; NOW THEREFORE:

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

- SECTION 1. The formation of a Sister City Affiliation between the City of San Antonio and the City of Mazatlán, Sinaloa, Mexico, is hereby approved.
- SECTION 2. Councilman Joe Alderete, Chairman, International Relations Committee, and Committee Members Councilwoman Helen Dutmer and Councilmember Joe Webb are hereby authorized to act as the official representatives of the City of San Antonio to carry out the intent of this Resolution.
- SECTION 3. That copies of this Resolution be sent to the Honorable Jose H. Rico Mendiola, Presidente Municipal of the City of Mazatlán, Sinaloa, Mexico, and to the Honorable Raul Gonzalez Galarza, Consul General of Mexico to San Antonio, Texas.


